PRIVACY STATEMENT

Learner records are legally required to be provided to government agencies within the training system where data is collected to oversee and improve the system as a whole. Personal information is collected for the purpose of providing services to our clients; the marketing new products and services; processing of payments; the provision of training; staging of events; identification of
